QUESTIONS:

Harvey Ouellette – Would you consider in your presentation a different column... 1st could be budget, but then a column included regarding the actuals for last year. Answer – Yes.

Marianne Bohr – If something comes up where you are needing more money for a ministry, how do you handle that. Answer – we use our budget as a guide more than following it exactly. All ministries share from the same dollar amount (bank account) so throughout the year we spend where needed and also hold back from spending if need be. Suggestion from Marianne to bring it to the congregation and give everyone an opportunity to give towards something new that comes up.

Lorne Johnson – Conference tithe, what is the percent? Answer – 1.87%, but our goal is to get it to 4%.

Teagan Gibson – How do you allocate money to ministries? Answer – we do a breakdown of all ministries and balance their giving. We have a fund set aside for seniors and young adults even though they do not have official pastors. Based on history, where we want to go, etc. Rod willing to share more of the breakdown after the meeting.

Bruce Schmidt – Why do we give to the BCMB Conference a percentage? Answer – we are one of the churches that has been part of the conference since 1950. Money goes towards supporting what the conference as a whole is doing. Conference also supports camps and CBC so our money goes towards that. Our money also goes towards church planting across the province.

Marianne Bohr – Thank you for the incredible job of putting together this budget. God Bless You.

- 11. **Motion: To engage KPMG as the review auditors for 2024-2025 fiscal year.** Moved by Brent Nesbitt, Seconded by Heather Neufeld (vote on ballot).
- 12. Motion: Amend bylaws: To amend the bylaws of Central Heights Church section 10 item 1 to read:

10.1 Central Heights Church shall convene for its Annual General Meeting within five months after April 30, the close of the church's fiscal year.

Moved by George Jacob, Seconded by Teagan Gibson (vote on ballot).

Rationale for change to bylaw 10.1: The current wording of this bylaw requires that we hold an AGM with two months of the church's year-end (April 30). This two-month timeline creates tremendous pressure on the year-end and financial statement preparation process making it very difficult to have the financial statements ready for distribution to the members two weeks prior to the AGM. So that an effective process can take place for this to run smoothly and to allow for effective governance, more time is needed between the church's year-end and the AGM date. We are therefore recommending that bylaw 10.1 be changed to convene the AGM within five months of April 30. Five months was selected to allow for flexibility when the AGM is held and to avoid convening it in July and August, which is vacation season for many of our members. Bylaw 10.3 requires that we host at least one Extraordinary General Meeting each year. The intention is to convene that additional meeting every April or May to approve the church's annual budget at the beginning of the fiscal year, and to convene the AGM every September to approve the financial statements and deal with other AGM business.

This bylaw change will result in active elder's terms being extended by 3 months as we transition to the new AGM timing.

13. **Motion: To affirm Matt Guynup to serve on the Elder Council for a 3-year term.** Moved by Nathan Archer, Seconded by Dale Collins (on ballot)

- 14. Motion: To reaffirm an Elder whose term has expired: Brent Nesbitt to serve on the Elder Council for a second three-year term. Moved by Marianne Bohr, Seconded by Elviera Funk (on ballot)

- 16. Report on Legacy Fund Ken Nickel
 - Capital fund for kingdom building activities. It is ideal for larger gifts of money that go beyond what is normally given towards the church budget.
 - 10% goes towards a special capital project or building maintenance fund for immediate use. 90% goes to missionary and/or leadership initiatives.
